

## The Graham Combat Killhouse Rules

#### 1. NOBODY IS COMING TO SAVE YOU

Whether an event lasts a few seconds, a few hours, or even a few days – you have to work as though nobody is coming to save you.

2. EVERYTHING IS YOUR RESPONSIBILITY

You are your savior, so start working because EVERYTHING IS YOUR RESPONSIBILITY. You are your security, you are your medic, you are your rescuer.

#### **3. SAVE WHO NEEDS TO BE SAVED**


You are your own best resource to SAVE WHO NEEDS TO BE SAVED. The New Hampshire House passed HB 1101, a Three Day Waiting Period Bill, to the Democrat controlled Senate on 18 February. It has a very good chance of being passed by the Senate.
