.22 RIMFIRE PLATE SHOOTS

We started our 2008-09 .22 Plate Shoot season with a bang - we had 34 shooters at our November 9th match. Unfortunately, with so many shooters, we only had time to shoot one match. We're reformatting our program to alleviate that problem.

Previously, a match consisted of three relays of five stations per relay. Starting this month, each match will be two relays of five stations. The match will be shot in squads, limited to 15 shooters. Each squad will be able to complete the match in about 55 minutes, so a new squad will shoot every hour. Squads will be assigned on a first come, first served basis.

The matches are open to the general public. All guns chambered in .22 Short, Long, or Long Rifle may be used, regardless of type or sights. Registration is from 11:00 to 11:45am, and the first match of the day starts at noon. Cost per shooter for your first match of the day is \$5.00 for CPF&G members and \$8.00 for non-members. Juniors (under 16) shoot for free with a paid adult. Cost for additional matches shot on the same day is \$3.00 each for everyone (Juniors still shoot free).

The kitchen will be open for food and drinks from 11:30am to around 2:30pm.

The remaining matches this season will be held January 11th, February 8th, March 1st, and April 5th. Hope to see you there!

Notice: Members who purchase on the Club's FFL will be responsible for an additional \$20 charge if products are shipped to the Club by FED/EX. Check to see how they ship. Ask for UPS or USPS.

POLITICAL NOTES

Federal: Obama Selects his Attorney General – So much for "I support the Second Amendment," and so much for the notion of "change."

President-elect Barack Obama has selected Eric Holder as his Attorney General. Holder, as Deputy Attorney General under Janet Reno during the Clinton Administration, said that the Second Amendment does not protect an individual right, but instead protects the right to have a firearm when serving with a militia. After leaving office, Holder stuck to that assertion when he signed Janet Reno's brief to the Supreme Court in the Heller case, "The which stated, Second Amendment does not protect firearms possession or use unrelated participation in a well-regulated militia."

At the Justice Department, Holder advocated a waiting period, limiting gun purchases to one per month, and so-called "gun show loophole" legislation—the fine print of which would have driven gun shows out of business. Holder made it clear that he, Clinton and Reno were more interested in stopping gun sales than in regulating

them. When ABC's George Will asked him about guns being used for self-defense more often than to commit crime, and Right-to-Carry states have lower crime rates than other states, Holder dismissed the facts that Mr. Will raised, with the flippant statement, "I'm not sure that we need more than the 200 million or so guns that we have on the streets." Just a small example of what we can expect coming out of the NEW Washington D.C. I hope you are ready.

New Hampshire: The Legislature will be gearing up in the Granite State this month. We have a lot of anti-gun sentiment floating around in Concord this session. I have not received a copy of proposed legislation. Be aware that not only our gun rights but our civil liberties in general could very well be under attack. We must be vigilant about watching all our rights.

Massachusetts: Things, as far as firearm rights, seem to be quiet in the Bay State. There are so many things happening with the politicians there it is difficult to keep up. I may need one of our Massachusetts members to step up and keep an eye on things and report back to us. If anyone is interested please contact me and we will work something out. Thank you.


