.22 RIMFIRE PLATE SHOOTS

Well, we wrapped up our 2008-09 22 Plate Shoot season back in April, averaging 28 shooters per match and enthusiastic comments from all. The word's getting around – we have a great time at these matches! Now we're getting ready to start the 2009-10 winter season and we anticipate even more shooters. Our first match is scheduled for November 8th.

We shoot on the outdoor range, regardless of the weather, so warm clothing and handwarmers will likely be the uniform-of-the-day. If it gets too cold, there's an enclosed heated area to warm up between relays.

We shoot two to four matches on each match day. One complete match consists of two relays of five stations, with eight targets per station, for a total of 80 shots. The steel plate targets vary from 2" to 6" in diameter, and are shot offhand at 25 yards. Shooters have 15 seconds to knock over their eight targets, and the winner is the shooter with the most hits at the end of the match. The big prize... Braggin' Rights! Match results and detailed information about rules and procedures are posted at <http://www.pineywoodsplace.com/cpfg22ps.html>

Participants in these events all use .22 Rimfire (non-Magnum) guns, but that's where the similarities end. We've had shooters using scope-sighted heavy-barreled rifles with 24X scopes, iron-sighted revolvers, and everything in between. We've seen open sights, aperture sights, red-dots, and scopes. We have separate classes for type of gun and type of sights, so Bolt Action rifles with scopes don't shoot against revolvers with iron sights. One thing all these shooters have in common are smiling faces. We have fun!

These matches are open to the general public and we generally shoot three or four matches each day. Registration is from 11:00 to 11:45, and we start shooting at noon. Cost per shooter for their first match is \$5.00 for Country Pond members and \$10.00 for non-members. The cost for second, third, or fourth matches shot the same day is \$3.00 each for everyone. Juniors (under 16) always shoot for free and may shoot from a rest if they wish.

The kitchen is open for food and drinks from noon to around 14:00.

This season's schedule of match dates is November 8th, December 13th, January 10th, February 14th, March 14th, and April 4th (the infamous "22 Easter Egg Shoot").

POLITICAL NOTES

Federal: The Obama circus
continues unabated in our nation's
capitol. We have mid-term elections
coming up in about a year. We need
our members to be informed to keep
your family and friends up to date on
all the issues including firearms issues.

The United States Supreme Court
has decided to hear the landmark
Second Amendment case of McDonald
vs. Chicago. The case will address the
application of the Second Amendment
to the states through either the Due

Process clause or the Privileges or Immunities clause of the Fourteenth Amendment. The case has major implications for the legality of restrictive gun laws not only in Chicago, but also in other cities across the country. The decision to hear the case, which will be argued later this year or early next year, gives Second Amendment advocates across America hope that this fundamental freedom will not be infringed by unreasonable state and local laws. New Hampshire & Massachusetts: Mayors Against Illegal Guns – Some local mayors have joined “Mayors Against Illegal Guns” (MAIG) which

was founded and is funded by activist anti-gun billionaire and New York City Mayor Michael Bloomberg.

Despite its very misleading name, this national group of anti-gun mayors has lobbied Congress against national reciprocity of state Right to Carry licenses

Against much needed reform of the federal Bureau of Alcohol, Tobacco, Firearms and Explosives (BATFE), for regulating gun shows out of existence and for repealing the Tiahrt Amendment that protects law enforcement personnel and protect lawful gun manufacturers from bogus lawsuits.

Bloomberg created “Mayors Against Illegal Guns” as a front group to lobby Congress to oppose important pro-gun reforms and support new federal gun control restrictions.

You can go to the NRA/ILA web site for a complete list of the mayors who have signed with this onerous group. NH had one mayor sign on, the mayor of Concord. After an avalanche of phone calls, letters and e-mails from his constituents he resigned from the group. Unfortunately our Mass members will find many mayors from the Bay State have enlisted including Mayor Menino who co-chairs the organization with Bloomberg.

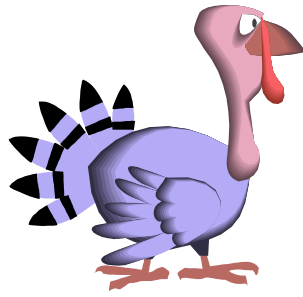
