



This has been a very strange legislative session in the state of New Hampshire. With a majority in both houses of our state government we, as gun owners and firearms activists, were expecting great things this year.

We had many promises and positive feedback from the politicians we worked hard to put into office. With as many as six pro-gun bills introduced, NOT ONE passed in the Senate. We worked with many of our state Representatives and Senators to put forth legislation that would take a lot of the burdens off of the law abiding citizen and keep guns out of the hands of people who do not obey the laws of our great state and country.


The three pro-gun state organizations, Gun Owners of New Hampshire, New Hampshire Firearms Coalition, and Pro-Gun New Hampshire tried to work together to achieve legislative success. There were differences of opinion of course that happen when people have varying ideas.

One of the really sad notes is that some of the politicians we helped, put politics ahead of the promises made to us.

The Gun Owners of New Hampshire usually sponsors and runs the annual Legislators Firearms Orientation Day (LFOD), which purpose is to get novice legislators, who have had no exposure to the shooting sports, the opportunity to learn who we are and what we do.

This year when we notified our usual volunteers, who provide everything from elephant guns to machine guns for this event, we were told in no uncertain terms that "they would not break bread with the people that screwed us over". Their words, not mine.

I would ask everyone who reads this to please pay attention to the rating sheets that GONH puts forth before every election and find out if your state Senator or state Rep was a friend or foe to firearms owners.
