


The New Hampshire Legislature has passed their version of "Constitutional Carry" and the bill (SBII6) has been sent to the governor's office.
Unfortunately, Governor Hassan has publicly stated several times that she will veto this legislation.

According to FBI crime statistics, Constitutional Carry in the state of Vermont and several other states has lowered the crime rates in these states. When law-abiding citizens carry legally concealed firearms, our communities are statistically safer than those communities that restrict the use of legally owned firearms.

Criminals do not get their firearms from the local gun shop or legal gun shows. They do not subject themselves



While New Hampshire has had licensed concealed carry for 92 years, recent court cases have changed our state's practice of allowing anyone who may legally own a firearm to carry one concealed. SB116 will fix this.
