

Politics & Legislation

New Hampshire

Once again I had a refresher course in politics on Wednesday, September 16, at the New Hampshire State House in Concord. The legislation "Veto Day", the first day of the new session, was an eye opener as usual.

SB 116, the "Constitutional Carry" legislation had a second chance for enactment. The political shenanigans started immediately. The bill was scheduled for 10 AM. At 9AM it was rescheduled for 1PM. After a few procedural changes it finally saw the light of day for reconsideration.

As the Union Leader describes it: New Hampshire will not be joining two of its neighboring states that eliminated the requirement for concealed weapon permits (licenses). The Senate, Wednesday, failed to override Governor Maggie Hassan's veto of Senate Bill 116, not reaching the two-thirds majority needed with a 14-10 vote along party lines. (Democrats have the Senate majority, for now).

The bill's prime sponsor, Senate Majority Leader Jeb Bradley (R – Wolfeboro), acknowledged the support was not enough to override the veto, but said he would bring the bill back again until the permit (license) requirement is eliminated. (Union Leader Thursday 9/17/15)

All the pro-firearm organizations represented at the State House knew an override was a long shot with a Democratic majority in the Senate. Despite that, we were out in force, trying to convince the Senate that an override was favored by a majority of law-abiding Granite State citizens.

Unfortunately, the higher authorities in the Chiefs of Police Association were vehemently opposed to this bill, mainly because they would lose some of their power over the people of our

state. Most rank and file police officers have no problem with law-abiding citizens carrying firearms, concealed or otherwise. True, there are exceptions in officers who have let their authority cloud their better judgement, but I believe they are not in the majority.

As Senator Bradley stated, the effort to make New Hampshire a "Constitutional Carry" state will continue until we join Vermont and Maine in trusting their law-abiding citizens to exercise their rights.

Federal

The Obama Administration is still pushing hard to have the United Nations Small Arms Treaty become settled law here. It is a direct violation of our Constitution, but that has never

bothered Mr. Obama in the past. I don't think our Constitutional Rights are a very pressing concern for him, considering he is hell-bent on giving 100 billion dollars in frozen Iranian assets to the largest sponsor of world terrorism known to man. The thought of Iran being a nuclear power scares the hell out of me for my children and my grandchildren.

All our Constitutional rights are important, but life, liberty, and the pursuit of happiness seem to have been ignored or completely forgotten by the Washington beltway crowd. We can correct this situation by the ballot box. Be vigilant and pay attention to the political process and we will all survive.


