Bylaw Changes

The following amendments to the Club Bylaws were enacted at the March Monthly Meeting.

Bylaws Section 2.2i, "Board of Directors", which previously read:

The Board shall ensure that all minutes of all meetings kept by the Secretary are accounted for in the month prior to the annual meeting, and that the minutes are retained by the Club Historian in a locked file cabinet with limited access.

was changed to read:

The Board shall ensure that all minutes of all meetings kept by the Secretary are accounted for in the month prior to the annual meeting, and that the official minutes are retained by the Club Historian in a locked file cabinet with limited access to said cabinet.

Bylaws Section 3.1b, "Membership", which previously read:

Any Sponsor must have been a Club Member in good standing for at least two complete years immediately prior to sponsoring any new Member.

was changed to read:

Any Sponsor must be a Club Member in good standing.

Bylaws Section 3.1d, "Membership", which previously read:

If the prospective Member or Members are accepted as CPF&G Club Members, the Sponsor will share complete responsibility for the new Member's actions for one year.

was changed to read:

A prospective Member, in lieu of a Sponsor, may submit the proper form to the Membership Committee, detailing that they have safely participated in five "Open to the Public" shooting events.

Bylaws Section 3.5g, "Honorary Member":

All Honorary Members will be automatically renewed each year.

was added

Bylaws Section 3.5h, "Honorary Member":

Honorary Members wishing range access must submit a renewal application form each year.

was added

Bylaws Section 3.6c, "Senior Member", which previously read:

must submit a request for Senior Membership at any regular meeting, or to the Vice-President during the membership renewal months.

was changed to read:

must submit a request for Senior Membership, prior to any regular meeting, to the Vice President, to be voted on by the membership.

Bylaws Section 3.6e, "Senior Member":

All current Senior Members in good standing will be automatically renewed as a Member each year.

was added

Bylaws Section 3.6f, "Senior Member":

Senior Members wishing range access must submit a renewal application form each year.

Bylaws Section 3.7f, "Life Member":

Life Members wishing range access must submit a renewal application form each year.
was added

Bylaws Section 3.12b, "Guests", which previously read:

If a Member brings a guest, the Member shall enter the name of the guest in the Range Log under Member's name and the town of residence in the badge number space. The word "guest" is unacceptable. For guests who are immediate family, the words "SPOUSE", "SON", or "DAUGHTER" may be used instead of town of residence.

was changed to read:

If a Member brings a guest/family member, the Member must enter the date, name of the guest in the Guest Range Log, the address/town of residence, relationship (spouse, son, or daughter) and the Member's membership number. For spouse and immediate family under the age of 18, the words "SPOUSE", "SON", or "DAUGHTER" may be used.

Bylaws Section 3.13, "LEO Member":

3.13 LEO Member

- a. May be extended to any person who holds current law enforcement credentials and who's department is under current contract with the Club;
- b. shall not vote;
- c. shall not hold office;
- d. shall not sponsor a person for Membership;
- e. shall have no other privileges of the Club other than range access;
- f. shall pay no dues;
- g. must sign a waiver upon each visit;
- h. cannot bring guests; and
- i. must follow all Standing and Range rules.

was added

Bylaws Section 10.3, "Dues and Surcharges", which previously read:

The last day for renewal of membership is the last day of the year. Members not renewing by that date will forfeit their Club membership. A former member in good standing for the preceding year may be reinstated, if requested prior to February 1st, and by paying their dues and a reinstatement fee, said fee to be determined by the Board of Directors.

What the Media Doesn't Want You to Know About Its Mass-Murder Narrative

A large group of unsuspecting people was waiting at a bus stop in Brownsville, Texas around 8:30 a.m. Sunday, when a Land Rover suddenly blew through a red light and barreled into their midst at a high rate of speed. The bus stop was located outside the Ozoman Center, which provides care for the city's burgeoning migrant community.

Eighteen people were hit, six were killed instantly, and two died later. Police said the driver, 34-year-old George Alvarez, has an extensive criminal record. A police spokesman described him as "uncooperative," adding that he tried to flee the scene and gave investigators several fake names. Alvarez is facing eight counts of manslaughter and ten counts of aggravated assault with a weapon. More charges are likely. The carnage he allegedly caused was the worst some officers had ever seen.

The story is already disappearing from legacy media newscasts and websites. There were no protests, marches, or calls to ban Range Rovers or other SUVs. No one filed suit against Land Rover or organized a boycott. No one from the White House went blood-dancing at the scene. The 24-7 coverage that normally follows a mass killing involving a firearm never materialized, because as horrific as it was, the Brownsville killings did not fit the legacy media's mass-murder narrative, for several reasons.

There are several factors the legacy media considers before deciding how to cover a mass murder. Here are the main considerations.

Race

Black lives do not matter to the legacy media, at least not as much. White victims always receive more media coverage than a killing spree where the victims are people of color. The race of the murderer matters, too. A white shooter will always generate more coverage than a Black, Asian, or Hispanic shooter. Downplaying or ignoring killings in a minority community is racist, but this is the type of racism the media allows. No one gets cancelled for what they don't cover. Unfortunately, this type of racism allows the killings to continue unabated, since without media pressure, elected officials know they can simply ignore the problem and hope it somehow goes away.

Weapon

If an AR or AK is used in a mass murder, the legacy media has prewritten stories ready and waiting to add to their coverage. These stories usually involve interviews with biased "experts" as well as anti-gun advocates. The media wants you to believe that "assault weapons" are responsible for most firearm murders, even though the data proves otherwise.

According to the FBI's UCR crime reports, there were 10,258 firearm homicides in 2019, but only 364 involved rifles – all types of rifles. The FBI neither defines nor maintains a specific data set for "assault rifles." The majority of the firearm homicides, 6,368, involved handguns. Knives or other cutting instruments were responsible for 1,476 homicides that year.

Motive

Today's cable TV news actors love to speculate about a mass-murderer's motive, as if someone who walks into a classroom or a shopping mall and starts shooting innocent people has a legitimate reason for their killings. Their actual motive is simple: they're crazy; they're deranged; they are extremely mentally ill. It doesn't matter if mommy and daddy didn't give them enough love and attention, or if they were bullied as a child. There is no justification for shooting innocent people. Nothing in their background can excuse such horrific acts, but this doesn't stop the legacy media from endlessly speculating about the "real reason" behind the deaths.

Politics

I worked in five newsrooms during my 20 years as an investigative reporter and editor and met scores of journalists from other organizations. I don't need all the fingers on one hand to count the conservatives, and only two of these were gun owners. Today's journalists may not be able to articulate the difference between a shotgun and a rifle, but they all have a firm grasp of politics – especially leftist politics. They would never violate the left's unwritten rule: Guns are bad. They would never stray outside the accepted political narrative; much less write a story that a shooting was justified. There are thousands of justifiable defensive gun usages every year. How many have you seen covered by the legacy media?

Gender

When a mass-murderer is male, the media usually tries and convicts them in the court of public opinion – justifiably so, most of the time. Nowadays, when a shooter is female or their gender identity is unclear, the coverage is much less accusatory. Sometimes it's even sympathetic. After Audrey Hale killed six people in Nashville's Covenant School and her gender identity became known, NBC News "pointed to an already combustible political environment in which transgender people have become a frequent target of right-wing lawmakers and pundits." Keep in mind three of Hale's victims were nine-year-olds.

Definition

CNN, FOX News, MSNBC, and even the Washington Post now rely solely on mass-shooting data from the Gun Violence Archive – an anti-gun nonprofit we debunked years ago. The reason is simple. The GVA inflates body counts, so its overblown numbers have become the data set of choice for the legacy media, which is constantly seeking more sensational headlines and news stories.

How does the GVA get its inflated numbers? They created their own definition of a mass shooting, of course. When most Americans hear the term, they picture a madman stalking the halls of a school or a shopping mall, coldly murdering innocent victims. What does not come to mind are rival drug crews shooting it out in Chicago, a deranged husband murdering his entire family, or a law-abiding gun owner acting in self-defense.

Yet for the GVA, and by extension the legacy media, anytime four or more people are killed or even slightly wounded with a firearm, it's labeled a mass shooting. For example, according to the FBI and its more conservative definition, there were 30 mass shootings in 2019. The GVA claims there were 417.

Proof

If you still don't believe the legacy media's coverage of mass murders is flawed and extremely biased, just look at the never-ending carnage in Chicago or any other large metro historically controlled by Democrats.

In Chicago this year, 852 people have been shot and 172 have been killed – and it's only May. Just last week, 60 Chicagoans were shot and six died as a result. That's more than the equivalent of one mass-shooting every week, but where is the news coverage? Where is the White House spokeswoman? Why isn't she denouncing these killings? Where are the interviews with Giffords, Brady, or Demanding Moms? Why aren't they claiming that the guns locked in our safes are somehow responsible for the Chicago deaths? Where are the so-called gun experts at the ATF? Why aren't they blaming Chicago's killings on bumpstocks, pistol braces, after-market triggers, or some other innocuous plastic accessory in common use? Where are the elected officials? Why aren't they leading demonstrations, protests or marches to bring awareness to the killings?

Bottom line, today's legacy journalists are nothing but hypocrites. If a mass-murder fits their narrative, they will cover it ad nauseum for weeks or even months. If it doesn't meet their specific criteria, they might mention it occurred, maybe, but only if no one is likely to become offended.



What's Your Position? Sometimes, the best stance isn't a stance at all

I really enjoy seeing some of the debates and arguments over whether the Isosceles stance or the Weaver stance is the best, so let's look at reality. I can't tell you exactly what a criminal will be doing when an attack begins, but one thing is almost certain—they won't be standing there all squared away like your silhouette target, waiting for you to get into the fighting stance you think is coolest.

Instead, the really dangerous criminals will use every advantage they can find. They'll try to catch you when you're least able to defend yourself, which might be when you're walking to your car with an armload of groceries, kneeling to pick up the keys you dropped, or when you're sitting or even lying down. In short, they will take every opportunity they can.

I recently read a study that shocked me because it said that the average person spends almost 10 hours per day sitting down. However, when you think about the time spent sitting in your car, at your desk at work, or in an easy chair at home, it makes a lot of sense. In spite of that, when was the last time that you worked on a pistol presentation while seated in one of your training classes? My guess would be never, simply because it's difficult to do with a class of any size on a square range, and most public ranges aren't going to allow it.

This and other oddball positions might best be practiced at home during a dry-practice session. I would even suggest that you set your real gun aside and do some drills using the inert plastic guns that we generally refer to as "blue guns" to be as safe as possible.

Considering the situation while seated, one might argue that the best thing to do is to stand quickly and draw the gun. But, that requires extra movement and time wasted, when time is mighty valuable. Also, when a person is in a vehicle, standing is impossible. The quickest move is to access their gun while seated and address the threat.

Other practice drills might involve getting the handgun into play while kneeling or lying down. Don't forget to work on defending yourself while on your back; you might be knocked flat at the beginning.

The key is to determine ways to get your defensive

handgun into play without covering yourself with the muzzle. In stressful situations, a self-inflicted wound is a distinct possibility, and one you obviously must avoid.

Another benefit of working out these oddball situations is that you may find out that your choice of handgun is not the best decision. Safeties and sights may cause problems you didn't anticipate. The same is true of holsters and the carry position you choose.

I have found that I have quicker access to my handgun when it is somewhere on the front side of my body, either appendix carry or crossdraw. After all, we spend most of our time with our hands on the front side of our body. In truth, it may only reduce a fraction of a second from our draw time but, when your life is on the line, fractions of a second can become very important. Another consideration favoring this type of carry is that I can draw the gun with either hand.

When driving on long trips, carrying my regular defense gun in a shoulder holster provides quick access to the gun. This is mainly because I have found that I can get in under the shoulder strap of the seat belt faster than if the gun is located at my waist.

It would be a mistake to change what you carry and the way you carry it simply because "that guy" from Shooting Illustrated does it that way. The smart move is to take the time to practice presentations from less than optimal positions and figure out what works best for YOU. Be concerned with safety and keeping control of the gun. Be concerned with getting a shooting grip on the gun and getting it on target as quickly and safely as possible.

I recently read a shooting report where the victim was wheelchair bound. He answered a knock at his door, only to have the door kicked open and his wheelchair knocked over. In spite of all of this, the victim got a hand on his gun and fired a shot as he was knocked over, stopping his attacker.

Just like that armed citizen, we need to plan for the unexpected and determine the most practical and quickest ways to deal with potential threats.
