### **Glock Discontinues Popular Models**

The news of Glock's decision to discontinue nearly its entire line of handguns has reached far beyond the gun community. The move comes after months of controversy over the infamous "switch" which easily converts Glock handguns to be capable of fully-automatic fire. Certain groups have taken advantage of this system, which can be easily made with a 3D printer or purchased online, to great effect. Violent criminal organizations have used Glocks modified in this manner in a number of shootings against other gangs, civilians, and law enforcement.




In light of these shootings, local and state governments have been cracking-down Glock switches. Certain states have even implemented bans on Glock sales entirely, believing that the handgun's original design is too easily converted with these aftermarket parts. The sensible 2A supporter can clearly see that these bans do not impact most Glock switch owners and only serve to make one of the most popular handgun platforms unattainable for the lawabiding citizen. Anyone with even a little common sense could see that such legislation is like banning the Lamborghini sales because their cars can break the speed limit too easily.

Unfortunately, it appears that Glock has given in to these backwards demands. Spinning the launch of their V Series handguns as a new and improved Glock, the company has bent to the will of politicians who know nothing about. These new models will, allegedly, not accept the available switches and be more difficult to convert for fully-automatic fire. This decision has led some to call for a boycott of Glock, citing their apparent cooperation with anti-gun legislation. However, it is important to remember that many firearm manufacturers have had such issues in the past. Smith & Wesson implemented its notorious internal locks for many years, for instance. Most manufacturers also produce "California Compliant" firearms that meet certain state requirements set forth by gun control legislation. While it is nice to have industry support in the 2A community, manufacturers are still businesses. By producing commodities that are available for purchase in all 50 states expands the number of available consumers. While Glock's decision to replace its handguns with the new V Series models feels like losing an ally in the fight against gun control, it is good business sense.

### Ruger-etta—The American Brand Taken Over by Italians



Beretta, as well known for its high-end sporting shotguns as its robust military and police sidearms (and its diminutive pocket pistols), silently purchased a significant share of Ruger stock. Beretta has expressed interest in a collaborative relationship with Ruger, but the exact details of this share purchase seem shady. While the business end of this deal remains murky, what could a future Ruger/Beretta collaboration look like for the consumer? Will we be gifted with a rugged, reliable, and affordable line of sporting guns with a classy Italian twist? Or, will we see import price tags on once affordable Ruger firearms? Only time will tell, but past Italian-American collaborations have led to great success (see *pizza*).



New Hampshire's grouse population has been lessened, but not by hunters. A three day trip to the woods above Errol, NH yielded zero birds in the pot, and only a few flushed. In fact, only a handful of shots were heard echoing through the mountains the entire weekend—a stark difference from the shooting gallery that the north woods were last season. So what caused this decline in the grouse population? The best theory we could come up with is the months of severe drought that New England has experienced, particularly in the northern parts of the region. Ruffed grouse prefer areas close to water sources, especially small mountain streams and wetlands, as these areas have the food sources they need and usually provide easy access to water. The drought has certainly reduced water levels in the woods, turning wetlands into sticky mud pits and once-flowing streams into barely detectable trickles of water. Perhaps this lack of water impacted the grouse population before hunters even got a chance to start the season. Hopefully a biological study of the matter will not reveal more dire news for the state's formerly prolific game bird. The views still made the trip worthwhile.

## **Zeroing for Deer in New England**



Hunting for Whitetails in southern and central New England means hunting small sections of woods, pushing thick laurel patches, and crossing the occasional field. While the New England deer hunter does not need to know their hold for 300+ yard shots, the art of zeroing a muzzleloader, shotgun, or rifle still applies. Regulation (and common sense) dictates that we use lower velocity rounds in this region, giving up the laser flat trajectories of high-power rifles. The point of impact can change dramatically between 25, 50, and 100 yards when using a low-velocity slug—enough to make the difference between a successful hunt and a track that ends in disappointment. I prefer to zero my firearms for a point-of-aim hold at 25 yards, making it easy to take aim when a deer jumps out of a nearby patch

of undergrowth. From there, simply knowing where to hold at longer distances will suffice for those rare occasions a New England hunter can spot their quarry across a field or marsh. A proper zero is still important in New England, and the time it takes to achieve this is well worth it come November.
